- 1. Fiscal Report (see attached)
- 2. Draft Allocations- overall anticipate a 6.16% overall increase in funding (12% DW increase)- We are waiting to hear when will learn our final allocation and when we will receive our first installment of PY22 funds. While there is not a big increase- won't even keep up with inflation- we are expecting to receive more than flat funding. We are continuing to spend down our PY21 and PY20 Youth funds and will know more in mid-June if we need to do a transfer from Adult to DW and/or ask for a waiver for the 80%.
- 3. WIOA Youth Partner Request and Response- Had several phone calls from WIOA partner utilizing Youth Build Funds. The program manager sent the youth to the One Stop- staff at the Center sent them to the Chamber Foundation. We received a call later saying that they wanted the youth in the One Stop Youth Program (GVP). We spent a week or more of staff time enrolling the youth, completing ISS's and working on placement. The Center then got a call complaining that the youth were not enrolled in YOS.

We (DCWIB) were then notified that a meeting was set up with the Youth One Stop Chamber Foundation staff and our Career Center Director (who has no direct report line to WIOA youth services). I sent a clarifying email to the YB Program Director and explained that if they wanted to talk to YOS- they needed to talk to the Chamber Foundation and Smart Staffing as both agencies serve the Youth One Stop.

After this meeting I received a call from the Chamber Foundation- stated confusion over the request and asked me what to do..

I reviewed the law and both our YOS program and this YB program offer very similar services so there should be no need to co-enroll... we each have funding to work with our youth. I am waiting for their Director to schedule a meeting, if they would like. Our position is- we are happy to help provide the services that they are unable to perform, to youth in their program (who come to us voluntarily). I will reflect this request in our next letter of support for their agency. I also followed up with the Chamber Foundation and explained my beliefs of services and the WIOA law.

- 4. Logo Approval- Both stacked logo and rectangular logo for DCWIB and One Stop are being recommended for usage. Color choice- one from line 1-4 and one from line 5-8. EC approved use of the new logo.
- 5. Presentation made to DC Legislative Budget and Finance Committee with Ron Hicks on May 5, 2022. I appeared in front of the DC Legislative Budget and Finance Committee, my report is attached. I receive 6 or 7 questions including- do we serve City of Poughkeepsie residents, what is our role in the homeless shelters, do we serve people who find us- or do we go out in the community? My responses include our presence with Beacon probation and work with Community Matters 2 and SNUG and our work with partners.
